The **2026 Ferry Pass** provides access to both the County and Township Ferries. The common fee structure for the Township and the County ferries will continue.

Annual ferry passes are to be purchased by January 15, 2026. Residents passing on the ferry after January 15, 2026, without a valid annual pass will be charged the regular fare for each crossing until such time as they purchase a pass.

Annual pass for a single vehicle,	\$300.00
One additional annual pass for a single vehicle in same name,	**\$100.00
Discounted annual pass for a single vehicle (65+),	*\$270.00
Discounted additional annual pass for a single vehicle in the same name,	**\$90.00
Two-way trip for single vehicle,	\$10.00
Two-way trip for single vehicle with trailer in tow,	\$20.00
Additional charges for annual pass holder with trailer in tow,	\$10.00
Two-way trip for any heavy vehicle,	\$20.00
Replacement fee per annual pass,	\$25.00
Trailer pass (Island resident who has purchased a vehicle pass),	\$300.00
Cyclist,	\$2.00
Friends and Family Pass (10 two-way trips for single vehicle),	\$75.00

These discounted fees apply to applicants who can show documentation indicating that they are 65 years of age or older during 2026.

** A second pass for \$100.00 will only be available if the second vehicle involved is registered to:

- The same individual who purchased the first full-price 2026 annual pass
- An individual who is married to or is in a common-law relationship with the full-price 2026 annual pass purchaser.
- The dependent child under the age of 18 of a full-price 2026 annual pass purchaser or the full-price pass purchaser's married or common-law spouse
- The dependent child over the age of 18 of a full-price 2026 annual pass purchaser or the full-price pass purchaser's married or common-law spouse, only if the dependent child has both the same permanent address as the full-price 2026 annual pass purchaser and is attending school full-time.

Please Note: A third pass at a reduced rate is not available. Documentation must be provided that satisfies the personnel issuing the passes.

Definitions

Single vehicle: car, motorcycle, van, SUV, or pickup truck

Heavy vehicle: any vehicle greater than 6000 kgs and/or 7 meters (23 feet)



Placement of the annual Pass Sticker

Please affix the sticker to the **PASSENGER SIDE** of the **front windshield**, at the **bottom**. This makes it easier for the crew to identify those vehicles that are not annual pass holders, and that need to make a payment.



Township of Frontenac Islands vehicles and vehicles that, through previous notification, the Township of Frontenac Islands identifies as undertaking Township business are exempted.

As directed by County Council, staff shall consider the following when loading the Frontenac-Howe Islander Ferry during the hours of 6:30 am to 8:30 am travelling off the Island and the hours of 4:00 pm to 6:00 pm travelling onto the Island (peak periods):

- One “heavy truck”, defined with a weight/length combination not to exceed 21 tonnes and 8.5 metres/28 feet, may be loaded during peak periods travelling in the identified directions as long as, in the opinion of on-duty staff, the “heavy truck” can be loaded efficiently and safely onto the ferry with 14 other vehicles or a combination of vehicles and trailers.
- Vehicles supporting agricultural operations are exempted from the above times.

Hours of Operation

As meal eating periods for the ferry workers depend on staffing levels and circumstances, the following can be used **only as a guide for the County ferry**:

Monday to Friday – Days (There is generally no disruption of service for these periods) 9:00 am to 9:15 am; 12:00 pm to 12:30 pm; 3:00 pm to 3:15 pm.

Weekends – Days (No service during these periods – some exceptions during the summer) 9:00 am to 9:15 am; 12:00 pm to 12:30 pm; 3:00 pm to 3:15 pm.

All Nights (No service during these periods)

9:00 pm to 9:15 pm; 12:00 am to 12:30 am; 3:00 am to 3:15 am.

These time periods are approximate to allow for repositioning of the boat to the mainland and may vary.
